

## SKIN SCRIPTS REJUVI PEEL

### What is Rejuvi peel ?

It contains a combination of glycolic acid, lactic acid and salicylic acid is an alpha-hydroxyl-acid (AHA) peel that is non-toxic to skin cells. AHA peels are very popular because they are very effective and produce minimal side effects.

### How does a Rejuvi Peel benefit me?

- Softens fine lines
- Wrinkle reduction
- Increased smoothness of skin texture
- Mild to moderate leveling of acne scars
- Lightening of pigmentation irregularities (age spots and dark spots)
- Even skin tone
- Increased skin moisture
- Increased skin radiance and glow
- Minimization of pore size

Glycolic acid combination peels are also believed to stimulate the growth of collagen (a protein that gives the skin structure).

### How does Rejuvi Peel work for me?

A glycolic peel is a superficial peel that gently exfoliates the damaged layers of cells that are covering healthy cells. Improvement in the appearance of the skin is usually obtained after a series of treatments.

### What can I expect during the treatment?

The treated area is cleansed and the peel solution is applied. The solution is left on for two to five minutes or as required. It is neutralized and followed by a custom designed post peel protocol. A few days after the treatment, your skin may look slightly red and may slightly peel, however you will notice a visible difference in the appearance of your skin, even after the first treatment. We will recommend an at-home regimen to maintain your new appearance.

We offer several different strengths of the Rejuvi peel. The higher the Level the higher the concentration, the deeper the solution will penetrate into the skin and can cause more damage to tissue

### Am I a candidate for Rejuvi Peel ?

Almost anyone can benefit from a glycolic peel. The best way to control aging skin and reverse skin damage is through a regular exfoliation regiment. Glycolic peels are the most gentle of all the chemical peel preparations available, yet provide great exfoliation for the skin. Results from a series of glycolic peels are comparable to deeper peels, without complications.

### How much downtime should I expect?

Glycolic peels are commonly referred to as "lunchtime peels" because they do not require long recovery periods or significant downtime. You can resume your daily activities, or return to work immediately after a glycolic treatment.

### Are there any contraindications for Rejuvi Peel treatment?

There are not very many contraindications to a glycolic peel; however, if you have a skin disorder such as psoriasis or rosacea, you would not be a candidate for this peel. Women who are breast feeding or pregnant are also not advised to have a glycolic peel.

### What should I do after a Rejuvi Peel ?

Immediately after **Rejuvi Peel** you should avoid exposing the treated area to the sun for three hours.

Three days following the treatment you should use a gentle cleanser, gentle moisturizer and avoid retinoid products or alpha hydroxyl products. If you plan to be in the sun, you should use a sun block with an SPF 30 or higher. Should you experience slight skin sloughing, make sure you do not scratch, pick or peel the skin while it is exfoliating.

## PLEASE READ THE FOLLOWING INSTRUCTIONS BEFORE YOU USE THE PEEL

### This peel is available in two strengths:

**Rejuvi Peel - LEVEL 1 (Glycolic acid 15 %, Lactic acid 10 %, Salicylic acid 1 %)**

**Rejuvi Peel - LEVEL 2 (Glycolic acid 25 %, Lactic acid 15 %, Salicylic acid 1 %)**

### Contents

1 X Rejuvi Peel in a glass bottle with a roller ball applicator, 2 X Alcohol swabs

1 x 15 ml Skin Scripts Skin Protect Post Peel

### **1. Perform a spot test prior to your chemical peel.**

- A patch test tells you how your skin will respond to the peel. The test should be performed on your forearm, or on a small area of skin below the ear at the hairline. Leave the test solution on for at least 1 minute before washing it off with water.
- Check the test patch after 24 hours. If skin looks normal around the test area, proceed with your peel treatment. If irritation like redness or tenderness appeared, lower the concentration of chemicals in the peel solution and try another test. If you had signs of an allergic reaction, such as raised bumps or itching, try a lower concentration or a different type of active ingredients (glycolic, salicylic or trichloroacetic acid) in your peel solution.

### **2. Clean your face before applying the chemical peel.**

Use water and a cleanser prior to your peel. Finish with an application of the alcohol swab that came with your chemical peel kit.

### **3. Apply an even coat of the chemical peel solution to the skin.**

Use small circular movements to roll on the peel, beginning with the less sensitive areas of skin around the forehead, chin and cheeks. Continue to apply the chemical peel below the eyes, nose and neck area. Make sure the solution is applied evenly, or your chemical peel results will be inconsistent. **CLOSE THE PEEL IMMEDIATELY AFTER APPLICATION TO PREVENT THE PEEL FROM LOSING IT'S ACTIVITY.**

### **4. Leave the peel on your skin for the recommended amount of time.**

Start with the LEVEL 1 peel and leave on for 1 (one) minute. Watch your skin for signs of irritation. While some burning is normal, if your skin begins to frost or sting intensely, remove the peel solution right away. Subsequent peel can be left on for 1 minute longer until you have reached the 5 minute maximum time. **DO NOT EXCEED 5 minutes for each peel.** If you want to increase the intensity of the peel you can start using the next strength or LEVEL 2 peel. The LEVEL 2 Peel must also start with a 1 (one) minute application time and increase in subsequent peel to a maximum of 5 minutes for each peel.

### **5. Remove the peel and apply Skin Protect (SPF30) .**

Your peel is designed to stop working as soon as it is washed off, and an additional neutralizer solution is not needed. Apply Post Peel Cream supplied in your kit. This will calm the skin and also prevent sun damage if you have to go into the sun.
